

However, other parameters and mandatory tests to be adopted for ensuring the quality check on material and overall work will be responsibility of the concerned Engg. officers.

The information displayed on the signboard will be for purposes of transparency and will ensure that there is no deviation from the specifications approved.

All concerned must follow the above instructions strictly in all the Road, Roofing, Boundary wall and capital works undertaken in the FCI Depots.
