Subject: - Addition of Special Condition under the head "Additional Conditions" in the MTF for Engineering works in respect of "**Provisions of Public Procurement (Preference to Make in India) order 2017 dated 15.06.2017** read with subsequent updated amendments and provisions of Rule 144(xi) of General Financial Rules (GFR) 2017 with subsequent updated amendments".

In continuation to approved MTF for engineering works, it has been decided that henceforth in all upcoming NITs, Model Tender Form for Engineering works will have following provisions as additional condition of contract for implying the provisions of Public Procurement (Preference to Make in India) as per orders of Ministry of Commerce and Industry and Rule 144(xi) of General Financial Rules (GFR) 2017 as per orders of Ministry of Finance.

S.no	Additional Condition to be added in MTF while calling NIT by tendering authority.
1	The bids are being invited as per the provisions of Public Procurement (Preference to Make in India) order 2017 dated 15.06.2017 read with subsequent amendments and updates issued from time to time and same is to be abided by the bidders, failing which, the bid will become void.
2	The bidder should ensure that Provisions of Rule 144(xi) of General Financial Rules (GFR) 2017 with subsequent amendments and updates are followed in totality and in case of any failure on this account, bid will become void.

Thus NIT approving authority and tendering authority is to certify **compliance of PPP -MII order before uploading tenders on CPPP and GeM.**
