विषय: Hiring of Storage capacity through PWS Scheme-2010 regarding.

महोदय,

On the aforesaid subject, references have been received from field offices regarding provisions of PWS MTF for hiring of warehousing services through GeM. The matter has been examined in HQrs and decided as under:

1. **Delegation of Powers:** The Delegation of Power (DoP) of GM (R)/ED(Zone) for availing warehousing services through PWS Scheme-2010 has been examined and revised as under:

A Hiring of Godown "With Services"

Sr. No.	Revised DOP	
	Level	Rates/Qtl./Month.
1.	GM (R)	Rs. 7.40/Qtl. /month
2.	ED (Zone)	Full Power

B Hiring of godown without services:

In case, the godowns is offered "Without Services", the above proposed DOP of GM (R) shall be reduced by Rs- 1.81 per Qtls. per month.

While exercising the DoP, following may be considered:

- i. The General Manager shall hire the godown under his DOP in consultation with finance and shall take prudent/judicious decision considering the requirement of storage space at the location, existing PWS/PEG rates in the Region, exiting market rates of warehousing services by private parties, CWC published rates in the Area etc.
- ii. If the godown is required to be hired beyond the DOP of General Manager (Region), he shall examine the rates quoted by the Bidder and furnish the proposal to Executive Director (Zone) with his recommendation.

- iii. Executive Director (Zone) shall examine the proposal of GM(R) in consultation with finance and shall take prudent/judicious decision considering the requirement of storage space at the location, existing PWS/PEG rates in the Regions/Zone, exiting market rates of warehousing services by private parties, CWC published rates in the Area etc.
 - iv. The Executive Director (Zone) shall examine the proposal of GM(R) with due diligence while exercising his DOP and decide the matter.
2. **Clarification on uploading of price bid:** Annexure-'D' of PWS MTF regarding "*LIST OF DOCUMENTS TO BE SUBMITTED WITH TECHNICAL BID*". Point no 3 of the annexure 'D' says "*Complete tender form with Annexure A, B, C, D, E, F & G duly filled & duly signed on each page by tenderer himself or by authorized signatory of the tenderer firm with following documents duly attested on each page by tenderer himself or by authorized signatory of the tenderer firm*". Since annexure-'C' is price bid, so there is a contradiction.

The point no 3 of Annexure 'D' is modified as "*Complete tender form with Annexure A, B, D, E, F & G duly filled & duly signed on each page by tenderer himself or by authorized signatory of the tenderer firm with following documents duly attested on each page by tenderer himself or by authorized signatory of the tenderer firm*"
