Reference has been received from Himachal Pradesh regarding reduction of minimum capacity to be hired in Hilly Areas through PWS 2010.

The matter has been examined in Headquarters considering the existing provisions and response in the recent PWS tenders and decided as follows:

The minimum capacity to be taken shall be 2500 MT. However, for Hilly Area minimum capacity shall be 1670 MT within one premises at a particular location shall be continued.

However, Executive Director (Zone) has been empowered to grant relaxation on case to case basis on merit for Hilly Regions only. Such relaxation should be done only in exceptional cases where there is no other viable alternative is available. This exercise shall be done prior to floating of PWS tenders and accordingly tenders shall be floated
