महोदय,

Please refer to the references referred above on the subject cited above. In this regard it is informed that the matter regarding examination/approval of rates by FCI of H&T Contracts awarded by CWC/SWCs for handling and transportation of FCI stocks stored in the godowns of CWC/SWCs has been examined in consultation with finance division and it has been observed that intervention of FCI in CWC working is not appropriate as it is an independent organization, with all duties attached to and abide by CVC guidelines etc. as well as is subject to scrutiny by their auditors.

However, GMs (Region) already have right to examine the cost of H&T rate as well as godown rent etc. and if found on higher side, may dehire such godown so that FCI is not at loss. Accordingly it is advised that concerned authorities of CWC/SWCs may be advised by GM (Region) to float/award the tenders of H&T strictly as per guidelines of CVC.

Further, it is advised that in case it is observed that the CWC/SWC rates are significantly higher than FCI rates the same must be brought to the notice of this office as well as MD, CWC. In case CWC/SWC rates are lower than FCI rates by 10 % or more, the concerned Regions may take corrective action as may be needed.

This issue with the approval of Executive Director (Storage).

Kindly refer to ZO(W) letter No. vigi./21(20)Gen.-4/2016 dated 12-01-2017, RO(Maharashtra) letter No. Vigi./21(3)/2016/RO.(Gen) dated 24-11-2016 the subject captioned above.

In this regard it is informed that the issues regarding appointment of H&T Contracts by CWC/SWC has already been examined at HQ level and instructions were issued vide letter No. S&C/QP/06/14/2010/Stg.VII dated 29-07-2010 and letter No. S&C/QP/06/04/2016/Inst./Stg.VII/3362 dated 24-05-2016, (Copy enclosed) which stipulates "that intervention of FCI in CWC working is not appropriate as it is an independent organization, with all duties attached to and abide by CVC guidelines etc. as well as is subject to scrutiny by their auditors. However, GM's(Region) already have right to examine the cost of H&T rate as well as godown rent etc. and if found on higher side, may dehire such godown so that FCI is not at loss". Accordingly it is advised that concerned authorities of CWC/SWC's may be advised by GM(Region) to float/award the tenders of H&T strictly as per guidelines of CVC".

You are requested to take further necessary action on the matter accordingly.
