विषय: Extension of Private Warehousing Scheme (PWS) beyond 31.03.2019 for 2 years reg.

महोदय,

The matter regarding extension of Private Warehousing Scheme (PWS) 2010 beyond 31.03.2019 has been reviewed. Competent Authority has approved extension of PWS 2010 for a further period of two years i.e. upto 31.03.2021 on the same terms & conditions as contained in this office circular no. E.3(28)/Pvt. Godowns/ 2008 dated 11.04.2012. However, DOP for hiring of godowns under PWS has been revised, so that GMs (Region) can sanction rates upto Rs. 6.76/qtl./month and EDs(Zone) upto Rs. 8.60/qtl./month. It is also ordered by the Competent Authority that proposal forwarded to Zonal Offices, for hiring should invariably be decided by ED concerned (Zone) within 10 working days.

2. In case, higher rates are received beyond the power of ED (Zones), the ED (Zone) will forward the proposal to ED (Storage) HQRS alongwith recommendation and full justification.

3. GMs (Region) are also advised that detailed analysis should be done and godowns, should be hired only with proper justification under this scheme and after following due procedures. GMs (Region) will be responsible for any under-utilization of hired capacity without justifiable reasons.
