विषयः Hiring of Partial Capacity and 'Use of Plastic dunnage (Poly Pallets) under PWS 2010 Scheme - regarding. Sir,

In continuation to FCI, Hqrs letter of even no dated 27.09.2019, 27.11.2019, 02.01.2020, 28.01.2020 and 28.02.2020, the matter regarding 'Use of Plastic dunnage (Poly Pallets) and 'Hiring of partial capacity' of the godowns to be hired under PWS 2010 scheme has been examined and decided as follows:

- 1. Use of Plastic Dunnage (Poly Pallets) :- In addition to the existing provisions for use of Wooden Crates, Use of plastic dunnage (Poly Pallets) is also allowed for the 'Lease with Services' godowns to be hired under PWS 2010 scheme.
- 2. Hiring of Partial Capacities:- As per the existing provisions, all warehousing units located within one unit for the premises shall be treated as an independent purpose of tender enquiry. The matter has been examined and it has been decided that in addition to the existing instructions, partial capacity of the offered godown of "Lease with Services" under PWS can be hired subject to the following conditions-
  - Partial capacities may only be hired in consuming regions as there is a possibility of replacing FCI stock with inferior quality stock in connivance with the bidder/miller in procuring Regions.
  - ii. Further, the partial capacities offered only on 'Lease with services' can be considered as in case of 'Lease only' godowns, the common infrastructure may lead to disputes between FCI and Godown owner/ other users for its use and maintenance.
  - iii. That the partial godown offered under PWS to FCI should be a separate shed with 'Lock & Key' exclusively for storing the stocks of FCI. Stocks other than that of FCI are not to be allowed for storage in Sheds offered to FCI.
