Sir/Madam,

Kindly refer to the above mentioned letters regarding Private Siding under FCI's PEG scheme 2008 & 2009 circulating the exemptions allowed by Ministry of Railways for railway siding godowns whose tenders have been finalized by FCI prior to the date of issue of letter by Ministry of Railway i.e. 21.08.2013 (copy enclosed).

Representations were received from Warehouse Owners regarding extension of time for completion of godowns with railway siding facility due to change in the Siding Policy by Ministry of Railways after the allotment of contracts. Matter has been deliberated by HLC in its meeting held on 07.11.2013 and with the approval of DoF&PD, it has been decided that further extension of a maximum period of one year from the date of exemption granted by Ministry of Railways i.e. 21.08.2013 may be allowed for completion of construction of railway siding godowns.

It is requested to take necessary action accordingly.
