CIRCULAR

Sub:- Model Tender Form in respect of Scheme for construction of godowns for FCI – Storage requirement through Private Entrepreneurs – 2008 and PEG - 2009 -- regarding approval to allow higher specifications for construction of godowns under PEG scheme.

Please refer to above mentioned letter/circulars regarding construction of godowns under PEG Scheme through Private Investors and Nodal Agencies. In regard to allow higher specifications than those provided in the MTF, a number of Representations from Private Investors have been received through various Regional Offices and Zonal Offices. The matter has been examined and the specifications higher than those provided in the MTF, for certain items of works have been approved by the competent authority. The approval was subject to the condition that extra expenditure if any, will be borne by the Investors only and not by FCI or Nodal Agency. The higher specifications have been conveyed for certain specific case and conveyed to ED (North) by the competent authority in respect of followings items:

1. To provide **Cement Concrete Blocks with crushing strength 150 Kg/cm² for construction of walls in place of Brick/Stone masonry** by S&C division for certain specific case and conveyed to ED (North) vide letter dated 27.03.2012 as mentioned above.
2. To provide **interlocking paver block of minimum thickness 80 mm of grade M-35** by Engineering division has been conveyed to GM (R), RO, Punjab vide letter dated 01.05.2012 as mentioned above.

3. To provide **Galvalume sheet roofing alongwith details of specifications instead of conventional roofing and 18 Nos. of Rolling shutters instead of 12 Nos. of Rolling shutters** in 5,000 MT capacity godowns by Engineering division has been conveyed to GM (R), RO, Bhopal vide another letter dated 01.05.2012 as mentioned above.

4. To provide **Kota Stone Flooring instead of Cement Concrete Flooring** by S&C Division has been conveyed to ED (North) and GM (R), RO, Rajasthan vide letter of even No. dated 11.05.2012.

5. The detailed specifications in respect of above mentioned higher specifications are enclosed at **Annexure - I**. In this regard, the letter dated 09.03.2010 (mentioned above) stands withdrawn.

If there are any specific requests in Zones for higher specifications, the same may be allowed to Private Investors for construction of godown under PEG Scheme subject to the condition that no extra expenditure will be borne by FCI or Nodal Agency on this account and extra expenditure would be borne by Private Investor. In this regard, an Undertaking may be obtained from the respective Investor/Firm. The Undertaking would be part of the Agreement executed between the Private Investor and Nodal Agency for construction of godown under PEG Scheme. There would be no reduction in designed/approved capacity of the godown on account of providing specifications higher than those enumerated in the MTF relating to PEG Scheme.

6. Such modifications will be allowed by ED (Zone).

7. This circular supersedes the letters dated 27.03.2012, 01.05.2012 & 11.05.2012 referred above.


