Please find enclosed herewith a copy of Ministry of CAF & PD, Deptt of Food, Govt. of India, Krishi Bhawan, New Delhi letter No. 20-3/2007-FC-II dated .28th July, 2008 alongwith a Scheme for construction of godowns for FCI - Storage requirements through Private Entrepreneurs -2008 for taking necessary action.

- You may take all the steps required to implement the scheme as per the guidelines given in the scheme. Also please ensure following steps on priority:
- i) General Manager (Regions) will prepare Master Plan for requirement of additional storage capacity in Regions. Since the guarantee periods of godowns constructed earlier under the seven year guarantee scheme are likely to be over soon, General Manager (Regions) will examine the utilization and requirements of given in the scheme.
- ii) While identifying the locations for requirement of additional capacity, full justification taking into consideration likely procurement in the area, available existing capacity, loading point (full rake loading facility) off-take for the four months (two months buffer stock + one month strategic reserve + one month operational stock) may be kept in view.
- point No.4 of the scheme which may be strictly adhered to.
- iv) After preparing the master plan indicating the requirement of additional storage capacity, location wise in the Regions, the same may be placed before the

State Level Committee. The recommendations alongwith full justification of the State Level Committee may be sent to the Headquarters at the earliest.

- Since the implementation of the Scheme is to be done in time bound mariner, the exercise for preparing the Master Plan of the Region, Constitution of the State Level Committee to consider the requirement of the additional storage capacity may be made immediately and the recommendation of the State Level Committee as per guidelines given in the scheme may be sent to the Headquarters as early as possible and latest by 30th September 2008 for further consideration of the High Level Committee/approval.
