The matter has been examined in consultation with Quality Control Division of FCI, Hqrs. and it has been observed that quantum and type of dunnage material has been duly mentioned at Sr.no. 1&2 in Annexure to Appendix-I of MTF under heading "Providing of necessary infrastructure for proper up keep of health of foodgrain stocks in godowns by the investors at warehouses" (copy enclosed). It is amply clear that bamboo mats are to be laid over wooden crates and cannot be used as a substitute of wooden crates. However, in case wooden crates are not available due to State Govt. restrictions, poly pallets conforming to BIS specifications may be used as dunnage material. You are requested to take action accordingly.
