Sub: For making PMS arrangements coterminous with the construction of godown

In its 34th meeting held on 20.05.2013, HLC has noted that Preservation, Maintenance, Security (PMS) arrangements are being delayed by the Nodal Agencies in many states as a result of which, taking over of the godowns is getting inordinately delayed.

As per decision of HLC, all nodal agencies under PEG Scheme are directed to make PMS arrangements coterminous with the construction of godowns so that there is no delay in taking over of godowns completed by private investors for want of PMS arrangements.
